Missouri has eight Congressional Districts (CDs) for which we are targeting six: CDs 1-5 and 7. We don't need signatures from CDs 6 or 8. You can see a "cheat sheet" for the counties and districts at [bit.ly/mocounties](http://bit.ly/mocounties).  
Multi CD County: A few counties have multiple CDs. For these leave the field blank if the voter is not sure of their CD number. You can fill the field in later using [bit.ly/modistrict](http://bit.ly/modistrict) to look it up.  
Single CD County: The rest of the counties have only one CD. For these it is best to fill in the CD field on line one when starting a new form, so it will serve as a reminder for all lines.  
 Four of the multi-CD counties contain parts of CDs 6 or 8. For example, Jackson county contains both 5 and 6. We need signatures from CD 5. CD 6 voters will not be counted. But it is fine to take the signature even if the voter is unsure of their district. It's better to risk getting a CD 6 signature that will not be counted than to miss out on a CD 5 signature.
